**RESTATED AND AMENDED ARTICLES OF ORGANIZATION

TUFTS UNIVERSITY ALUMNI ASSOCIATION, INC.**

ARTICLE II

*The purpose of the corporation is to engage in the following activities:*

The Corporation is organized and shall be operated exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws (“the Internal Revenue Code”), including securing for Tufts University the hearty and united support of her graduates and of encouraging a cordial good fellowship and fraternity of interest among the same. The Corporation may engage in any activities in furtherance of such exclusively charitable, educational, and scientific purposes which may lawfully be carried on by a corporation organized under Chapter 180 of the General Laws of the Commonwealth and which is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

### ARTICLE III

*A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of elections or appointments, the duration of membership, and the qualification and rights, including voting rights, of the members of each class, may be set forth in the by-laws or may be set forth below:*

1. There shall be two classes of members of the Corporation:
  - A. General Members:
    - i. All persons who have received a degree from Tufts University, or from the Eliot-Pearson School, the Boston School of Occupational Therapy, the School of the Museum of Fine Arts prior to the affiliation of such schools with Tufts University, or any other school that later becomes affiliated with Tufts University; and
    - ii. Persons who have attended Tufts University but do not otherwise meet the requirements of subsections 1(A)(i) above, *provided* that the governing body of the Corporation has voted to approve such person or persons as members of the Corporation.
  - B. Director Members: All General Members who are also members of the Alumni Council or such other body by any other name as shall constitute the governing body of the Corporation.
2. General Members shall have the right to elect, and the governing body the right to re-elect, alumni trustees to the Board of Trustees of Tufts College. The proportion of General Members needed to elect alumni trustees shall

be based solely on the General Members who have voted in such election and not on a proportion of the General Members in total.

3. The following actions of the Corporation require, in addition to any other approvals required by the by-laws of the Corporation, the approval of such proportion of the General Members as is required for members' approval of such action by Massachusetts General Laws Chapter 180 or any law that succeeds or replaces it:
  - a) any amendment of the Corporation's articles of organization that diminishes the rights of the General Members as they are stated in these restated articles of organization;
  - b) the sale, lease, exchange or other disposition of all or substantially all of the Corporation's assets if such transaction involves or will result in a material change in the nature of the activities conducted by the Corporation; and
  - c) the consolidation or merger of the Corporation.
4. A petition for dissolution of the Corporation must be authorized by both the governing body of the Corporation and two-thirds of the General Members who have voted on such petition.
5. Any amendment of the Corporation's articles of organization other than one that diminishes the rights of the General Members of the Corporation as they are stated in these restated articles of organization shall be approved by the Director Members in such proportion as is required for members'



approval of any amendment of the articles of organization by Massachusetts General Laws Chapter 180 or any law that succeeds or replaces it.

The by-laws of the Corporation may set forth the designation of additional classes of members of the Corporation, the manner of election or appointments, if any, of members of the Corporation, the duration of membership, and the qualification and rights, including voting rights, of the members of each class, *provided* that the bylaws may not diminish the voting rights accorded to the classes of members in these restated articles of organization.

#### ARTICLE IV

*Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or any class of member of members, are as follows:*

Subject to the limitations set forth below, the Corporation shall have the following powers: (1) the powers set forth in Massachusetts General Laws c. 156B, §9 (a) through (k), §9(o) and §9(p); and (2) the power to be a partner with one or more other organizations in any enterprise which carries out the purposes on which the Corporation's tax-exempt status is based.

(a) Notwithstanding any other provision of these articles of organization, the Corporation shall not carry on any activities not permitted to be carried on (i) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(b) No part of the net earnings of the Corporation shall inure to the benefit of any private individual, and no member, trustee, director, officer, or employee of the Corporation shall receive any pecuniary benefit except in exchange for the provision of services or assets of equivalent value or as otherwise permitted in carrying out the purposes of the Corporation.

(c) No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation (except to the extent permitted by Section 501(h) of the Internal Revenue Code), and the Corporation shall not participate in, or intervene in (including the

publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(d) The governing body of the Corporation may make, amend, or repeal the by-laws in whole or in part, except with respect to any provision which by law, the articles of organization or the by-laws require action by the members.

(e) In the event of any liquidation or dissolution (whether voluntary, involuntary, or by operation of law), the property or assets of the Corporation remaining after providing for the payment of its debts and obligations shall, except as may be otherwise required or prohibited by law, be distributed pursuant to Massachusetts General Laws c. 180, §11A, for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code that are similar to the purposes of the Corporation. A petition for dissolution consistent with such laws must be authorized by the governing body of the Corporation and approved by the members of the Corporation.

(f) At any time that the Corporation is a private foundation within the meaning of Section 509(a) of the Internal Revenue Code:

- (1) The governing body of the Corporation shall make distributions for each taxable year at such time and in such manner as imposed by Section 4942 of the Internal Revenue Code.
- (2) The governing body of the Corporation and the members of such body shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; nor retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; nor make any investments in such manner as to incur tax liability under Section 4944 of the Internal Revenue Code; nor make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.

(g) No member of the governing body, director, or officer of the Corporation shall be personally liable to the Corporation for monetary damages for breach of fiduciary duty as a member of the governing body, director or officer; provided, however, that this paragraph shall not eliminate or limit the liability of a member of the governing body, director, or officer of the Corporation (i) for any breach of the governing body member's, director's, or officer's duty of loyalty to the Corporation, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, or (iii) for any transaction

from which the governing body member, director, or officer derived an improper personal benefit. No amendment, modification, or repeal of this paragraph, directly or by adoption of an inconsistent provision of these Articles, shall apply to or have any effect on the liability or alleged liability of any governing body member, director, or officer of the Corporation for or with respect to any acts or omissions of such governing body member, director, or officer occurring prior to such amendment, modification, or repeal.

(h) The Corporation shall to the extent legally permissible and consistent with the Corporation's tax exempt status under Section 501(c)(3) of the Internal Revenue Service Code indemnify each of its present and former governing body members, directors, and officers and any person who serves or has served, at the Corporation's request, as director, trustee, officer or member of another organization (and the heirs, executors and administrators of the foregoing) (collectively referred to as the "Indemnified Person") against all expenses and liabilities which the Indemnified Person has reasonably incurred in connection with or arising out of any action or threatened action, suit or proceeding, whether civil, criminal, administrative or investigatory, in which the Indemnified Person may be involved, directly or indirectly, by reason of serving or having served in a capacity identified above. Such expenses and liabilities shall include, but not be limited to, judgments, fines, penalties, court costs and attorney's fees and the cost of reasonable settlements. However, no such indemnification shall be made in relation to matters as to which such Indemnified Person shall be finally adjudged in any

such action, suit or proceeding not to have acted in good faith in the reasonable belief that his or her action was in the best interests of the Corporation and with respect to any criminal action or proceeding, had no reasonable cause to believe that his conduct was unlawful.

Indemnification may include payment of reasonable expenses in defending a civil or criminal action or proceeding in advance of the final disposition of such action or proceeding, upon receipt of an undertaking by the Indemnified Person to repay such payment if the Indemnified Person shall be adjudicated to be not entitled to indemnification hereunder, which undertaking may be accepted regardless of the financial ability of the Indemnified Person to make repayment.

In the event that a settlement or compromise of such action, suit or proceeding is effected, indemnification may be had, but only if such settlement or compromise and such indemnification are approved:

- i. by a majority vote of a quorum consisting of disinterested members of the governing body of the Corporation;
- ii. if such a quorum cannot be obtained, then by a majority vote of a committee of the governing body of the Corporation consisting of all the disinterested members of such governing body;
- iii. if there are not two or more disinterested members of the governing body in office, then by a majority of the members of the governing body then in office, provided they have

obtained a written finding by special independent legal counsel appointed by a majority of the members of the governing body to the effect that, based upon a reasonable investigation of the relevant facts as described in such opinion, the person to be indemnified appears to have acted in good faith in the reasonable belief that his or her action was in the best interests of the Corporation; or

iv. by a court of competent jurisdiction.

The foregoing right of indemnification shall not be exclusive of other rights to which any Indemnified Person may be entitled as a matter of law. The Corporation's obligation to provide indemnification under these articles of organization shall be offset to the extent of any other source of indemnification or any otherwise applicable insurance coverage maintained by the Corporation or any other person.
