



Chris Whittier is an Assistant Professor and directs the Conservation Medicine program at the Cummings School of Veterinary Medicine at Tufts, where he also received his veterinary degree (V'97). He earned his Ph.D. from North Carolina State University. He previously worked for Gorilla Doctors, the Smithsonian, and as a consultant with World Wildlife Fund. He has lived, worked, studied and traveled across much of Africa spanning 5 decades and more than 15 countries. Dr. Whittier strives to use and share that experience with students and travelers to focus attention on complex African conservation issues, especially those impacting wildlife.

He is an avid wildlife photographer, has appeared in a number of wildlife documentaries, and has had field and laboratory research and photographs published in a variety of scientific journals, magazines, and books.

PROGRAM ITINERARY

September 11, 2024 — Depart for Windhoek

Depart the U.S. for Windhoek, Namibia (flights not included.)

*You have an opportunity to arrive a day early. The cost of the early arrival hotel is \$285 per night inclusive of breakfast. Please contact Immersion Journeys to make your arrangements.

September 12 — Arrive Windhoek, Namibia

Welcome to Namibia! Windhoek ("wind corner" in Afrikaans) is the commercial and legislative capital of Namibia. Developed around a permanent water source by the indigenous pastoralists- it was later modernized by the Germans in the 1840s. One can still see the German influence in architecture and food when in the city. Welcome dinner at hotel and safari briefing by your guide.

Overnight: Windhoek Luxury Suites (Welcome Dinner + 2 glasses wine, beer or soft drinks)

September 13 — Windhoek | Outjo

Depart for Outjo. On the way, stop at the AfriCat Foundation located in the Okonjima Nature Reserve. Experience the work they are conducting to protect leopard and cheetahs and reintroducing them into the wild.

Onward to Outjo. Your lodge is home to the endangered rhino. Here you will see firsthand the conservation work being done to protect these gentle giants. Evening game drive. Overnight: Kifaru Bush Camp (B, L, D) * Drinks on purchase.

September 14 — In Outjo

Morning guided walk: identify some of the more than 250 bird species in the area, including Enjoy a day of rhino tracking and behind-the-scenes access to their Rhino Momma Project. Overnight: Kifaru Bush Camp (B, L, D) * Drinks on purchase.

September 15 — Outjo | Etosha National Park

Continue north to your lodge situated on the outskirts of the Etosha National Park. Arrive in time for a late afternoon game drive in the Etosha National Park.

Etosha meaning "place of dry water," encompasses a huge, flat calcrete depression (or "pan") of about 5,000 square-kilometers. The pan provides a great, parched, silver-white backdrop of shimmering mirages to an area of semi-arid savannah grassland and thorn scrub. The pan itself contains water only after very good rains and sometimes for only a few days each year but is enough to stimulate the growth of blue-green algae that lures thousands of flamingos. Etosha attracts all the major predators as well as the endangered black rhino. It is a scene from "Noah's Ark" as herds of animals take their turn at the watering holes.

Overnight: Etosha Safari Lodge (B, L, D) * Drinks on purchase



September 16 — Game drive in Etosha National Park

Full day game drive in the Etosha Game with a picnic lunch. Overnight: Etosha Safari Lodge (B, L, D) * Drinks on purchase

September 17 — Etosha | Damaraland

Continue to Damaraland. This area is huge, untamed, and ruggedly beautiful region of Namibia leaving most travelers in awe. Here one can see prehistoric watercourses with open plains and grassland, massive granite koppies and deep gorges. Stop at a Himba village. The Himba are semi-nomadic herders and have managed to maintain much of their traditional lifestyle. You will also visit two geological wonders: Burnt Mountain- created by solidified lava some eighty million years ago, and the Pipe Organs. These are rock formation that comprises a group of columnar basalts which resemble organ pipes

Overnight: Twelfelfontein Adventure Camp (B, L, D) * Drinks on purchase.

September 18 — Day Trip to Twyfelfontein

We head to Twyfelfontein today. The area has been inhabited for 6,000 years, first by hunter-gatherers and later by Khoikhoi herders. Both ethnic groups used it as a place of worship and a site to conduct shamanist rituals. In the process of these rituals at least 2,500 rock carvings were created, as well as a few rock paintings. Displaying one of the largest concentrations of rock petroglyphs in Africa, UNESCO approved Twyfelfontein as Namibia's first World Heritage Site in 2007. Overnight: Twelfelfontein Adventure Camp (B, L, D) * Drinks on purchase.

September 19 — Damaraland | Swakopmund

Later we continue South to Swakopmund- a beautiful coastal town on the Atlantic ocean. Founded by the Germans in 1892 in an effort to establish a deep sea harbor, today it remains a thriving town with a strong European influences as seen by the architecture and also a place for locals to come during the hot summer season due to its proximity to the ocean. The rest of the day at your leisure to enjoy on your own. Overnight: The Delight (B, Lunch en route) * Drinks on purchase.

September 20 — Swakopmund | Walvis Bay Excursion

After breakfast depart to Walvis Bay for a full day excursion on a catamaran in search of the Marine Big 5: whales, dolphins, mola, leatherback turtle and seals. The route takes us past oyster farms as you approach Pelican Point with its landmark lighthouse and 60,000 resident Cape Fur Seals. In season (July to November), larger mammals such as the Southern Right whale and humpback whales are often spotted, while other whale species, such as the Gray whale and the Pygmy Right whale have made appearances. A light lunch will be served on board.





Later, head to Sandwich Harbor which boasts two distinct wetlands and associated mudflats. One is aquifer-fed and supports typical emergent vegetation, but is slowly disappearing due to natural causes. The second, under tidal influence, consists of mudflats and raised shingle bars. Wedged between the sea and the Namib Dunes, it is one of Namibia's most important coastal wetlands, supporting eight endangered species among the large numbers of wading birds. Several archaeological sites dating back 1,000 years exist within the site.

Overnight: The Delight (B, Lunch on the cruise) * Drinks on purchase.

September 21 — Swakopmund | Sosussvlei (Namib Desert)

Fly by small bush plane to the Sossusvlei area followed by a short road transfer to your lodge. The sand dunes of Sossusvlei in the Namib Desert are often referred to as the highest dunes in the world. Various arguments are laid out to support this claim, but all miss the point, which is that Sossusvlei is surely one of the most spectacular sights in Namibia and well worth the visit.

Overnight: Desert Grace Lodge (B, L, D) * Drinks on purchase.

September 22 — Sossusvlei

An early morning departure to Sesriem- the entrance to the Sossusvlei Dunes. This is the best time to see the dramatic colors of the dunes change as the sun rises over the horizon. The drive to the heart of Sossusvlei is around 60km and en-route you will find Dune 45, one of the largest dunes.

Explore the beauty of the petrified trees of Deadvlei and ascend these dunes. Considered some of the tallest dunes in the world, even surpassing those of the Sahara, these monumentally high star-shaped dunes are a sought-after destination for photographers and artists. The warm tint of the sand contrasts with the dazzling white surfaces of the clay pans in the surrounding areas. The hues constantly change with the sun rising from deep apricot to warm red and all shades in between. Overnight: Desert Grace Lodge (B, L, D) * Drinks on purchase.

September 23 — Sossusvlei | Windhoek | Departure

Fly back to Windhoek. Met on arrival and assisted with airport check-in formalities for your onward flight back to the U.S. or onward adventure to Cape Town (see details below.)

Level of difficulty: Easy to moderate.

Due to the nature of the areas we will be visiting, this program involves some walking on uneven terrain or up and down stairs possibly without handrails. Accommodations will be in luxury properties, but note that they are located in remote locations, operating under challenging natural conditions (weather systems and animal movement) and may not offer all the amenities that big city based luxury hotels provide. Travel between places of interest will be by a combination of a coach, small plane and safaris will be conducted by 4x4 specially equipped safari vehicles often over bumpy terrain. Some days will involve long drives through desert landscape. Outdoor temperatures will range from 60-90 Fahrenheit depending on the time of the day with bright sunny conditions. Every effort will be made to ensure your comfort however it will be the responsibility of the guest to advise the tour operator and Tufts University regarding any concerns you may have. Please consult with your doctor regarding this trip, its length and location and share this brochure with them.

PARTICIPANT'S AGREEMENT

By signing our tour reservation form, or otherwise indicating your assent in writing, you agree to the terms and conditions set forth in this document. These terms and conditions apply to the Tour, the itinerary for the Tour and payment for the Tour

INTRODUCTION: These are the terms and conditions applicable to the tour packages provided by Immersion Journeys LLC and Tufts University (collectively "Immersion Journeys", "Tufts University", "we", "us" and "our"). The terms "client" "you" and "your" refer to each person who purchases and/or uses a tour package provided by Immersion Journeys.

RESERVATIONS AND PAYMENTS: A deposit of \$1,200 (or \$1,450 per person including Cape Town extension) of the total Tour cost, along with a completed and signed tour reservation form are required in order to confirm your reservation. Upon receipt of these forms and your deposit, we will confirm your trip. Your signature on the tour reservation form confirms that you have read this Participant's Agreement.

The balance of your Tour cost is due of 90 days prior to departure.

TRAVEL INSURANCE: We strongly recommend that you purchase trip cancellation insurance. In the event that you must cancel your participation in a travel Tour, trip cancellation insurance may be the only source of reimbursement. Trip cancellation insurance is available for comprehensive coverage of such expenses in conjunction with cancellation due to illness or accident, and damaged or lost luggage. In addition, medical evacuation coverage may be required as a condition of booking. **Please contact Mary Ann R. CANCELLATION AND REFUND POLICY: Our cancellation charges are based on the stringent payment policies of our suppliers of local services and therefore represent a reasonable estimate of our loss. Cancellation charges are expressed as a percentage of your total trip cost (excluding commercial airfare) and also depend on the day you cancel and the day of your scheduled departure from your home. Our cancellation charges are in addition to whatever the airline may charge you:

There is no refund for unused portions of a tour once it has commenced, and you are solely responsible for costs incurred by you due to missed, cancelled or delayed transportation. or for any other reason will be deemed a cancellation. If a flight or other delay for any reason prevents you from joining the Tour on the Tour start date, you will be considered a no-show. No refunds will be available, but you may join the Tour late if you wish.

Commercial airline tickets must be paid in full at the time of ticketing. Airline cancellation charges are set forth on the invoice.
